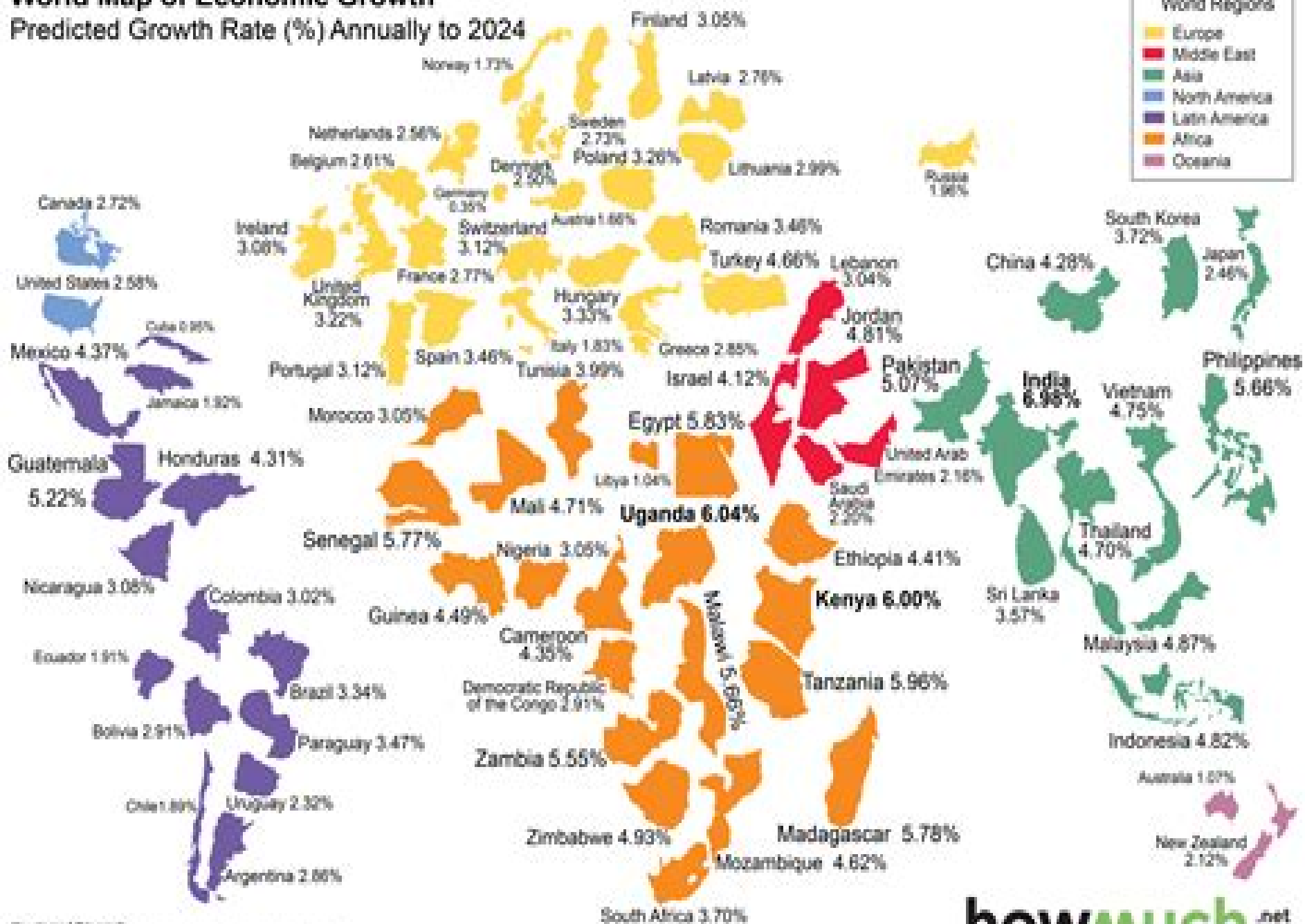


World Map of Economic Growth
