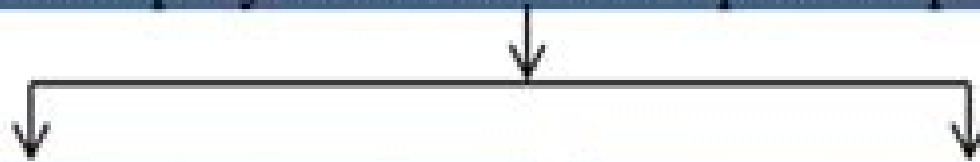


CONVERTIBLE DEBENTURE
