**If the Omitted Procedures were important to expressing the opinion, and are still important in supporting the previously reported opinion, AND parties are currently, or likely to be, relying on the audit report:**

- **Attempt to perform the procedures or alternate ones.**
- **If results alter original conclusions, treat as discovery of new facts and take similar notification action to that on previous slide.**
- **If unable to perform, consult attorney as to actions to satisfy responsibilities to client, SEC and persons relying on the auditor's report.**
