

We the People of the  
insure domestic Tranquility, provide for the common defence,  
and our Posterity, do ordain and establish this Constitution,  
Article I

Section 1. All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

Section 2. The House of Representatives shall be composed of Members chosen every second Year by the People of the several States, and in each State shall have Representatives apportioned among the States according to their respective Numbers, which shall be determined by adding to the whole Number of free Persons, including those bound to Service for a Term of Years, and not including Indians not taxed, three fifths of all other Persons. The Electors in each State shall have the Qualifications requisite for Electors of the most numerous Branch of the State Legislature.

Section 3. The Senate shall be composed of two Senators from each State, chosen by the People of the several States, for six Years; and there shall be one Senator from each State in addition to the Representatives chosen by the People of the several States.

Section 4. The Times, Places and Manner of holding the Elections of Senators and Representatives, shall be regulated by the Laws of the United States, but the Congress shall always assemble once in each Year, and such Congress shall be the first Session, unless otherwise provided by Law.

Section 5. The Senate shall have the sole Power to try all Cases of Impeachment. When sitting for that Purpose, they shall be on Oath or Affirmation. The President and Judges shall also be on Oath or Affirmation.

Section 6. The Senators and Representatives shall receive Compensation for their Services, which shall be ascertained by Law. They shall, in all Cases, except Cases of Impeachment, be privileged from Arrest during their Attendance in Congress or on their way to and from Congress, and for all Speeches and Debates in Congress.

Section 7. All bills for raising Revenue shall originate in the House of Representatives; but the Senate may propose or concur with Amendments as to the Form of such Bills. All bills which shall have passed both Houses of Congress shall, before they become Laws, present to the President; and he shall sign them; but he may withhold his Signature, and they shall not be in Force until he shall have signed them; or he may veto them, and they shall not be in Force until he shall have signed them.
