

MANAGEMENT PREROGATIVES

Management prerogative:

- An exclusive and special right, power or privilege granted to business owners.
- Property right attributed to the owner of a business establishment

Par.4, Sec. 3, ART. XIII, Philippine Constitution: "The state shall regulate the relations between workers and employers, recognizing the right of enterprises to reasonable returns of investments, and to expansion & growth."

ART. 428 of the Civil Code: • "The owner has the right to enjoy and dispose of a thing, without other limitations than those established by law."

The owner of a business establishment has, among others, the right to control or direct its business, the right to its fruits and the right to dispose the same, subject to the regulations of the police power of the state.

Example.

When an owner of a business enterprise, after operating a profitable business for several years and decides to close the same for he is already tired of doing business and wants to travel abroad for vacation, absolutely, he CAN CLOSE the business. However, he is obliged to pay separation pay to workers as mandated by law. (Art. 283, Labor Code.)

The company has the exclusive right to purchase labor from any person whom it chooses. Thus, the transferee in good faith of a business establishment has no obligation to absorb employees of the transferor and to continue on employing them. (MDII Employees Association vs Presidential Assistant on Legal Affairs, 79 SCRA 40)

There is no law which requires the purchaser to absorb the employees of the selling corporation. As there is no such law, the most that the purchasing company may do, for purposes of public policy and social justice, is to give preference to the qualified separated employees of the selling company, who in their judgment are necessary in the continued
