- We will discuss the 'Agreement to Act' with you and send a copy for you to sign.
- Once you have instructed us, we will investigate your potential claim in more detail.
- If required we may instruct an independent medical expert to assess your case to determine whether the care provided fell below an acceptable standard and resulted in harm and injury.
- If the medical expert's report is supportive, we will obtain a second medical report which details your current condition and future prognosis.



STEP 3: NEGOTIATION WITH THE HEALTHCARE PROVIDER

WE CONTACT THE DEFENDANT.

- We will write a formal Letter of Claim to the hospital / GP surgery / clinic involved. The letter will set out the allegations of the negligence and the healthcare provider must respond within 4 months stating whether they admit or deny liability.
- If the healthcare provider admits liability, we will begin settlement negotiations.
- If your healthcare provider does not admit liability, and your case is sufficiently strong, we will support you in continuing your compensation claim through the Court process.



STEP 4: COURT PROCEEDINGS SECURING YOUR COMPENSATION.

- We represent you and pursue your claim in Court.
- The judge will review your case and determine whether the defendant is negligent.
- If so the judge will make a determination on the level of compensation to be awarded.
