The ultimate user of the goods or services is consider as consumer or Who buys a goods for the purpose of satisfying his/her own needs and wants is considered as consumer.

Definition of Consumer:

According to sec.2 (1)(d) of Consumer Protection Act of 1986, "Any person, who buys any goods against consideration is a consumer".

According to **Oxford dictionary**, "Consumer is a person who purchases goods and services for personal use".

Consumer dispute:

According to sec. 2 (1)(e), of Consumer Protection Act of 1986, "Consumer Dispute refers to a dispute where the person against whom a complaint has been made, denies or disputes the allegations contained in the complaint. Thus it is clear that if a person against whom complaint is made agrees to the complaint, there is Consumer Dispute".

Complaint:

Under sec. 2(1) (c), complaint is defined as "Any allegation in writing made by complainant that,

- Any unfair trade practice or restrictive trade practices adopted by any trader burdening a consumer with loss or damage.
- Defective goods bought or agreed to be bought,
- ⇒ Deficiency in service availed or agreed to be availed,
- ⇒ Price charged in excess of fixed or displayed price,
- ⇒ Hazardous goods and services being offered for sale."
- ⇒ The complaint can be attached with receipt, invoice guarantee or warranty cards, correspondents and so on

Who can file a complaint? Or Complainant:

A complaint in relation to any goods sold or delivered or agreed to be sold are delivered or any service provided or agreed to be provided may be filed with a consumer forum by
