Size gives a company power, and that power requires regulation.

As companies grow their ability to affect those around them also grows.

Today's companies have grown to a massive scale, with many of the world's largest companies generating revenues

That dwarf the gross domestic products of many countries.

How entities this large can be effectively regulated is a central challenge of company law and governance.
