protections and corporate ownership demonstrates that shareholder rights got stronger on paper from 1882 to 2001 with a minor setback in the 1990s while equity ownership got increasingly more concentrated after 1940 I end by suggesting that increasing popular participation in financial markets might be a good way to commit governments to protect investors
