Globalization and the Diffusion of Media Policy in Africa: The Case of Defamation of Public Officials

Abstract

The legal and policy transfer perspective holds that due to asymmetric power relations between nations, policy diffuses from global centers of power and influence to the periphery of the international relations system. Over the years, aspects of the landmark New York Times v. Sullivar decision handed down by the United States (US) Supreme Court have diffused to Africa. This paper analyzes how law and public policy standards protecting journalists from the wrath of government officials in defamation cases have diffused from the US to the African Commission on Human and Peoples' Rights and the African Court of Human and Peoples' Rights. These African judicial bodies received. contextualized, and Africanized international defamation principles with respect to public officials. This piece also explores how four African countries-South Africa, Kenya, Uganda, and Zimbabwe-have echoed the public policies set forth in New York Times v Sullivan in specific cases involving media defamation of powerful government officials. This development bodes well for freedom of expression in Africa, a continent that has had the unfortunate reputation of being the home of authoritarian "strong men" who've ruled over regimes of law and disorder.
