According to *sec.2 (1)(d) of Consumer Protection Act of 1986*, "Any person, who buys any goods against consideration is a consumer".

According to **Oxford dictionary**, "Consumer is a person who purchases goods and services for personal use".

Consumer dispute:

According to *sec. 2 (1)(e), of Consumer Protection Act of 1986*, "Consumer Dispute refers to a dispute where the person against whom a complaint has been made, denies or disputes the allegations contained in the complaint. Thus it is clear that if a person against whom complaint is made agrees to the complaint, there is Consumer Dispute".

Complaint:

Under *sec. 2(1) (e)*, complaint is defined as "Any allegation in writing made by complainant that,

- ⇒ Any unfair trade practice or restrictive trade practices adopted by any trader burdening a consumer with loss or damage,
- ⇒ Defective goods bought or agreed to be bought,
- ⇒ Deficiency in service availed or agreed to be availed,
- ⇒ Price charged in excess of fixed or displayed price,
- ⇒ Hazardous goods and services being offered for sale."
- ⇒ The complaint can be attached with receipt, invoice guarantee or warranty cards , correspondents and so on

Who can file a complaint? Or Complainant :

A complaint in relation to any goods sold or delivered or agreed to be sold are delivered or any service provided or agreed to be provided may be filed with a consumer forum by
